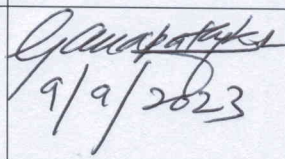
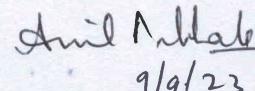

2. Suggestions/ Comments/ Recommendations for Improvement:

The committee feels that the college should carefully exercise their new autonomous position for the overall development, improvement of student learning outcomes to meet the long term vision laid out by the college and the NEP. Centers of Excellence should evolve in an interdisciplinary manner and students should be encouraged to take a wider breadth of electives to meet their career goals. The committee suggests that greater automation should be used for overall administration and record maintenance. A large language model (LLM) search can be implemented for ease of information retrieval. A greater emphasis should be laid on obtaining CSR funding to augment research resources and seed funding for faculty. Explore external registration programs at IITs, IISc and NITs for faculty development. A mentoring committee for newly recruited faculty to be implemented at the department level. Accreditation of the new UG and PG programs should be pursued and international/national conferences and workshops to be organized on campus.

3. Conclusion:

The committee feels that the college is taking the right steps to take advantage of their new autonomous position. Overall there is a strong sense of commitment to all aspects of the educational process and the committee commends the college faculty and staff for this pursuit and vision.
