SUMMARY OF THE IQAC EXTERNAL PEER TEAM REVIEW

1. Observations:

- b) Explore research collaborations with neighbouring technical institutions like IISc Bangalore, NITK Surathkal, NIT Calicut and MIT Manipal.
- c) Have at least two student counsellors (one male and one female)
- d) Better to have a designated person as a safety officer to ensure that the safety procedures are followed in the campus and periodically conduct safety drills.
- e) Health insurance scheme may be introduced for students and staff.

3. Conclusion:

Overall SJEC displays a strong commitment towards academics, quality teaching with due emphasis on developing their research and IP footprint. The OBE policies are a positive aspect of the academic system. The suggestions from NEP are also getting implemented. Faculty and staff of the Institute are highly motivated and the committee wishes them very best.
