Thereafter the surrendered seat will be offered to the other deserving candidate. If not, a candidate is required to pay the balance fees to the College within five days from the reporting date of the PGCET first round failing which, reserved seat will be cancelled/amount will be forfeited.
- 4) Increase in Tuition / College Fees to be followed as per government policy
- 5) Academic rules & regulations are to be followed from the College website. ( www.sjec.ac.in )
